In case the Expo is extended for more than three days, extra payment for each extended day(s) beyond 24 days shall be made at the rate not exceeding proportionate cost for 24 days. On completion of the Expo, the contractor shall have to take away all materials within 02 days and shall have to vacate the site. He shall have to pay Rs.40,000.00(Rupees Forty Thousand) per day or as per the rule of Nagar Nigam, Ahmedabad for the days he occupies for vacating the site beyond the period allowed thereof.
- 3. The Expo ground shall be formally made available to the Contractor by the Expo Authority on as is where is basis from 10.02.17 .The construction work must start immediately at site on the same day and be completed and handed over to the Expo Authority formally by 22.02.17 at 10.00 am positively. The progress of the work shall be checked and supervised by officers duly nominated by the Expo Authority to ensure that the work is done as per specifications and in fixed time schedule. Tenderer are advised to inspect the site for physical conditions before basis of actual work executed and on their(s) initially approved. For extra fittings contractor will tendering

In case any portion of work is not completed as per time schedule, specifications and handed over to the Expo Authority on the due date penalty up to 5% on the total value of work allotted/awarded will be imposed per days by the Expo Authority and that part of the work may be allotted to any other contractor.

However, Security Deposits, if required shall be made by the Expo authority and letters to the concerned authorities shall also be addressed by the Expo authority. Security Deposits, installation charges and consumption charges for all civil and electrical connections for the duration of the Expo shall be paid by the Expo authority, the contractor will, however, have to pay all security deposit, installation and consumption charges both civil and electrical work for the duration he takes over the ground to the time he formally handover the complete work of the Expo to the Expo Authority.
- 9. In regard to electrical fitting etc. the contractor shall have to engage a qualified license Electrical Contractor entitled to erect, handle and maintain high tension supply line and its upkeep and maintenance.
- 10. The Contractor shall not use any materials other than the specified in tender without the prior permission of the Expo Authority.
- 11. 25% amount as a first installment of approved tender will be paid on seven days before the date of expo starting and recommendation and inspection of the committee formed by expo authority for the same and as per conditions of clause 4 of tender 25% amount as a second installment will be paid after five days of Expo starting date and recommendation and inspection of the committee formed by the Expo authority for the same 30% amount as a third installment will be paid after the completion of Expo and recommendation and inspection of the committee formed by Expo authority for the

SPECIFICATION FOR INTERIOR AND EXTERIOR WORK OF THE HANDLOOM THEME PAVILION

- 1. The Handloom Theme Pavilion of Development Commissioner for Handloom will be based in a covered area of 1500 sq. ft. in prominent place.
- 2. The Theme Pavilion will be constructed and the entire design work will be executed by the contractor under the overall supervision of the weavers' service center. Ahmedabad Office of Development Commissioner for Handlooms in accordance with the designs and layouts appended. It should be ensured that sufficient walking space would be provided with proper landscaping. The display work in the pavilion will also be executed by the contractor under the supervision of office of Weavers Service Centre, Ahmedabad, Development Commissioner for Handlooms and this would involve weaving on looms, designs, textures, fabrics, R&D work, decorative etc. The exhibits for display will be supplied by the Weavers Service Centre, Ahmedabad Office of the Development Commissioner for Handlooms to the Contractor for safe carriage to the Expo, which will be returned to the office of the Weavers Service Centre, Ahmedabad, Development Commissioner for Handlooms intact on conclusion of the event.
- 3. The structure is to be made from 4" 'A' class pipe pillars, 3" rafter and 2" purline covered with 3' to 10' long new GCI sheets. Maximum/minimum heights roof on either side will be 16'/14' respectively and is to have enough slope. The roof should be waterproof and should withstand wind, rain, storms etc. False ceiling should be properly fitted with the roof in the approved shape and design in off-white handloom cloth so as to maintain a uniform height of 13' from the floor. There should be proper gridding of 4'x4' for false ceiling, Lighting and display. The floor should be of block board 1" thick at a height of 18' from ground with proper bracings not more than 2 apart, covered with approved natural coir-mat. The outer gap between the ground and the floor should however, be covered with ply. Steps at both Exit and entrance should be provided to enable the visitors to the Expo to have an easy access.
- 4. Windows with appropriate design are to be provided at the front facia. The facia will have "Theme Pavilion" written in English and the regional language along with the Handloom Symbol. The entrance and exit gates will be as per direction of Theme Pavilion In-Charge.
- 5. Lighting and ventilating arrangements are to be in accordance with the required standards. Electrical light and fan-fittings are to be provided with necessary wiring of main line separately for fan, light, night-lamps, distribution and point wiring including switch, main switch, etc. using **ISI:** standard wire and light fittings complete as may be approved by the Authority.

Construction should take into consideration fire and security hazards. Requisite fire-fitting equipment, emergency light and adequate exhaust fans etc. should be installed in the Pavilion.

6. The following material is to be provided by the Contractor in the Theme Pavilion:-

DETAILED SPECIFIACTION

1) Fire Brigade Office/Garage: Hanger type structure-24'x32'

2) Bathrooms /W.C.S.:

Contractor have to provide covered bathroom and WCs' for the use of the participants and visitors on round the clock basis. Sufficient water supply has to be ensured by the contractor and arrangement for handling soiled/dirty water are to be made on large scale enough to handle the expected volume of rush. Setting tanks, septic tanks, sok-pits, sever line and main holes etc, as mandatory under CPWD manuals as to be provided to run WCs and bathrooms at the Expo. The rates of WCs and bathrooms therefore, should be inclusive of all these provisions.

a) WCS: Total 4 sets fo wC blocks consisting of 10WCs in each block at site as indicated by the Expo authority. Internal size of WC is 4'x4',height 6 ½' from platform level. Roof and the partition should be with GI sheets without imperfection or holes. The WC (Indian type) sheet and its platform will be 1'x1/2' high form ground level made of brick work in 1:3 cement sand with top finish of 1" thick IPS flooring with necessary slope in floor as required Lockable door with necessary fittings should also be provided. The fitting of door should be in such a way that privacy is maintained. Each bock of WCs have an overhead Water Tanks of 500 Ltr. Capacity and enable round the clock water services. Water taps in each with we may also be provided. WCs and toilets indication of Gents/Ladies should be made. Electrical fittings and provision of 100 watt bulb to be provided in each WC Each WCs should be equipped with buckets/mugs. Full time sweepers should be engaged for each block of WCs to ensure cleanliness throughout the Expo. The WCs should be ready at least two days before the commencement of Expo.

b) Bathing Places:

A9" raised masonry platform from ground level with cement plaster 30' long and 5' wide having 1/2IPS flooring over it with proper slope is to be constructed and a 5'x4.5" thick brick wall 30" with 1:4 cement mortgage also to be constructed at one end of platform to support 10 Water tapes, Drainage of waste water should also be properly arranged. There should be no spreading of water by over flow or leakages in the disposal system. An overhead Tank of 2000 Ltr. capacity should be constructed to enable round the clock water facility.

c) <u>Urinals:</u> Providing urinals at 3 places with Urinal Stalls in each has been made from a brick wall of 4'height of 16' length with 4"partision walls to go between each urinal duly plastered, a platform of 16'x3' with

brick work duly plastered is to be providing for standing. The platform should have proper slope for drainage. A gutter is to be provided at the base of the back will and platform and drained as directed. Urinals will be hand flushed. Round the clock water facility should be made available at all Urinals.

d) Storage and distribution of Water supply:

The contractor is to provide for the storage and distribution of water through out the Expo grounds.

- i) Main storage plastic tank to be installed at high point with a capacity of 5000 liter inlet from the main water line and outlet to the smaller tanks with proper plumbing and connection should be ensured by the contractor throughout the Expo period.
- ii) Four smaller tanks of 500 liter capacity to be fixed on 4 WCs blocks and a 2000 liter capacity tank at bathing place with both inlet from the main tank and outlet to the required areas with proper plumbing and connections must be ensured by the contractor throughout the Expo period.
- iii) Twenty no. of self closing railway taps of ½" dia are to be provided at two places with round the clock drinking water supply must be ensured by the contractor throughout the Expo period.; Proper drainage of water must be ensured to avoid any water logging/stagnation.
